1 Recommendations

1.1 It is recommended that the Committee

1 Approve the parking areas and Remote footpaths listed in Appendix 1 for addition to the Statutory List of Public Roads.

2 Background / Discussion

- 2.1 A request from the Scottish Government has been made through Grampian Housing Association to have various parking areas and footpaths in Peterhead adopted by the Council. Following remedial works to bring the areas up to an adoptable standard they are now submitted for adoption.
- 2.2 The roads and footways associated with this report are listed in the attached schedule “Additions to the Statutory List of Public Roads” (Appendix 1) and on the attached plan (Appendix 2).
- 2.3 The roads and footways have been completed to a satisfactory standard and are acceptable for adoption.
- 2.4 The Head of Finance and the Monitoring Officer within Business Services have been consulted and have no comments to make.

3 Equalities, Staffing and Financial Implications

- 3.1 An equality impact assessment is not required because the recommended actions don't have a differential impact on people with protected characteristics.
- 3.2 There are no staffing implications associated with this report.
- 3.3 Future maintenance costs for the roads will be incurred. These costs will be accommodated in the annual Revenue Works Budget.

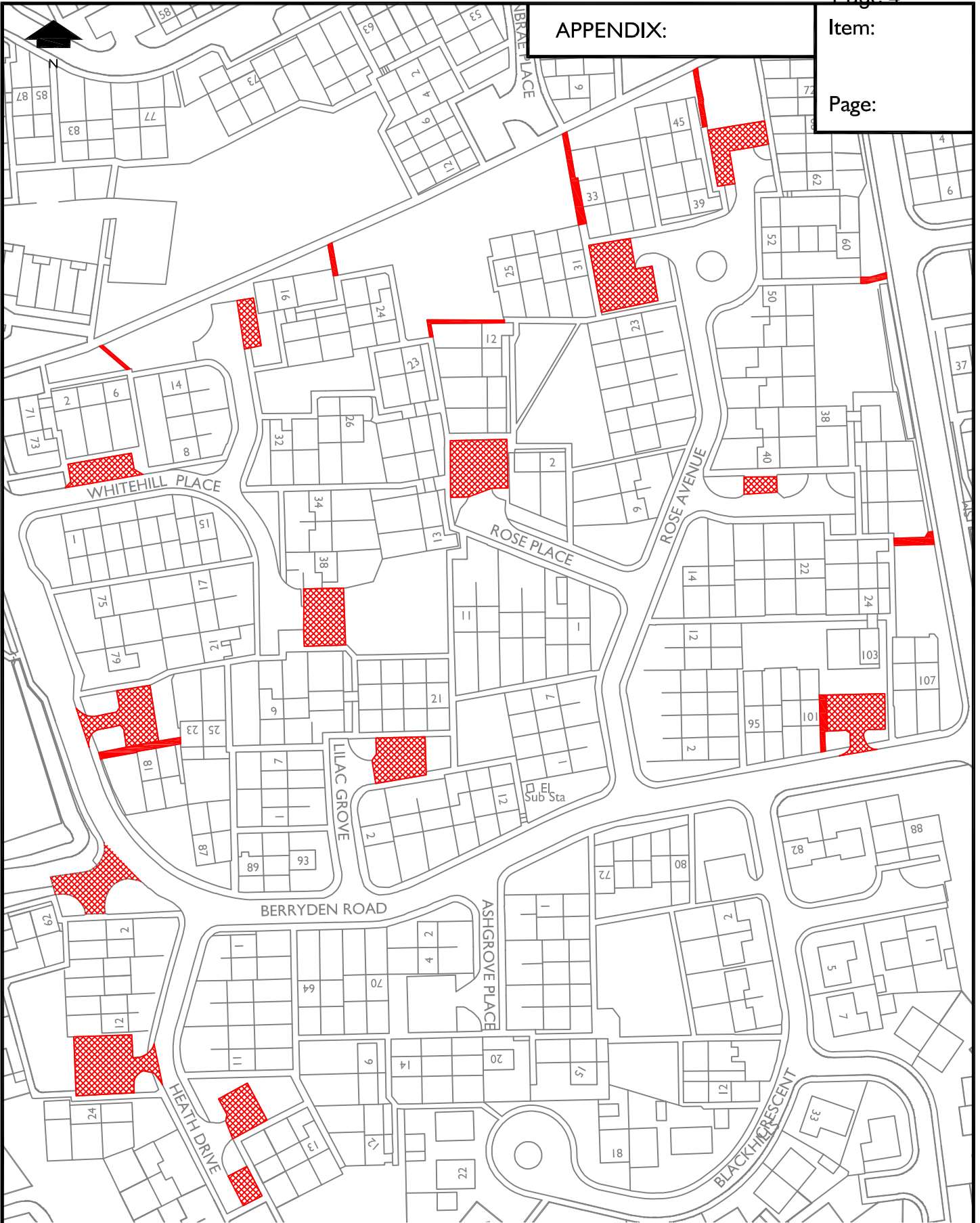
