# 5. REVISED ADEN RTIF PROJECT – TOILET PROVISION AND ELECTRICAL UPGRADES CONTRACT

A report by the Director of Infrastructure Services had been circulated advising that at the Buchan Area Committee Meeting on 22<sup>nd</sup> June 2021 the Committee approved the Aden RTIF Project Supplementary Directorate Procurement Plan. Following the results of the Aden RTIF Project "Aden Country Park – New Changing Places Toilet Provision & Electrical Upgrades" competitive tender exercise, the project value has increased, and, as a result, the Committee is now being asked to acknowledge the revised Aden RTIF Project Procurement Plan.
