

REPORT TO BANFF & BUCHAN AREA COMMITTEE - 25 JANUARY 2022

EDUCATION & CHILDREN'S SERVICES MID-YEAR PERFORMANCE MONITORING REPORT – APRIL TO SEPTEMBER 2021 (COUNCIL PRIORITIES: AREA PLAN 2021-2023)

1 Executive Summary/Recommendations

1.1 The purpose of this report and accompanying appendix is to provide an update on the progress with key council area outcome indicators identified as provided by the Education & Children's Services Directorate, which help demonstrate how we are delivering on the Aberdeenshire Council Plan Priorities (2020-2022) framework linked to the Banff & Buchan Area Plan (2021-2023), and consider how the Service is progressing, evidenced through a reflection of the performance achieved during the first six months of the reporting year 2021/22 (April to September 2021), in order that Committee can acknowledge progress and fulfil their scrutiny and monitoring role.

1.2 The Committee is recommended to:

- 1.2.1 Acknowledge and consider progress made during April to September 2021 toward achieving the Council Plan Priorities 2020-2022 linked to the Banff & Buchan Area Plan 2021-2023; and
- 1.2.2 Instruct the Director of Education & Children's Services to continue to present performance reports to the Area Committee on a six-monthly basis, evidencing progress and performance with delivery of the Council Plan linked to the Banff & Buchan Area Plan.

2 Decision Making Route

- 2.1 In light of the unparalleled impact of Covid-19 on Aberdeenshire communities, the economy and on public services, Full Council formally closed down the former Council Plan 2017-2022 and associated priorities at the special meeting of 23rd July 2020¹ (Item 4), and approved a renewed Council Plan 2020-2022 at the special meeting of 7th October 2020² (Items 3 and 3a) to better reflect the current challenges being faced by the council and the region centric to the three pillars³ Our People, Our Environment, and Our Economy.
- 2.2 The Education & Children's Services (ECS) Directorate Plan and accompanying Directorate Improvement Action Plan 2021/22, which provide more detail around how the renewed outcomes are to be delivered with a

focus on performance and improvement – setting out high level key themes for performance measures and benchmarking to monitor the progress of our key actions, and accountability for delivery – was considered and approved most recently at ECS Committee on 27th May 2021 (Item 11). As agreed, the Service primarily leads or collaborates on the council priorities and associated outcomes:



To secure continuous improvement in outcomes for ALL children and young people (Council Priority 1)



To have better, integrated working arrangements in pursuit of improved outcomes for children and young people (Council Priority 2) Efficient and effective business support, advice and regulation (Council Priority 3)



To develop and deliver a revised LLA Business Plan focused on the three pillars of Live Life Outdoors, Live Life Well and Live Life @ Home (Council Priority 27)

- 2.3 The Banff & Buchan Area Plan is the delivery vehicle for Directorate Plans at an area level, providing a clear performance and scrutiny framework and aims to capture the synergies and relationship with Directorate Plans. Area Plans are, in part, informed through Directorate Plans, Council policies and locally based information to reflect the needs and priorities of the area and it's communities. The current Area Plan covers the two year period 2021-2023, and was considered and approved at Banff & Buchan Area Committee on 25th May 2021⁶ (Item 7).
- 2.4 Performance information in relation to Education & Children's Services key Directorate project actions and outcome indicators are presented to the ECS and Communities policy committees, in line with their scrutiny remit, with the latest mid-year update presented to ECS Committee on 2nd December 20217 (Item 10). Those outcome indicators with an area perspective are also considered by the five other council area committees (outlined in their council area plans), in line with their remit of determining matters which directly affect their areas and making recommendations. Updates on the progress with delivery and impact of projects and actions within the Banff and Buchan Area Plan is scheduled to be presented separately, as outlined in the area performance calendar considered at area committee on 14th December 20218 (Item 10).

3 Discussion

3.1 A high-level summary overview of the progress made during April to September 2021 in relation to key Directorate outcome indicators with an area perspective updated during Q1 or Q2 2021/22, can be found in the discussion below with a focus on Council Priorities 1 and 27, with fuller details of progress made provided in Appendix 1.

- 3.2 Due to the nature of education data, most of the outcome indicators linked to the Council Priorities (2020-2022) and Banff & Buchan Area Plan (2021-2023) that are reported to Area Committee, provide whole-of-session data, therefore are reportable on an annual basis released at varying times during the following reporting year within the biannual update closest to when the data is released. Details on those due to be reported later in the performance reporting year is provided in Table A of Appendix 1.
- 3.3 During the first six months of this reporting year (2021/22), the Service has continued to adapt their response to the Covid-19 pandemic, with the impact influencing the services ordinarily delivered by ECS that persisted from the initial national lockdown which commenced 23rd March 2020 which had begun to ease during this latest six-month reporting period. Following the periods of imposed physical school closures, schools were able to reopen on a phased approach from late February 2021 and remained open throughout the early months of the new school session (beginning August 2021).
- 3.4 Although overall performance across Q1 and Q2 2021/22 has continued to be heavily affected compared with services provided pre-pandemic, performance updates reported to policy and area committees for this mid-year period continue to outline the many positive, flexible and innovative ways the Service has adapted to offer support and maintain engaged with our service users and communities virtually and embedded alternative means of providing services.

- As the focus has remained on establishing and maintaining safe operational delivery, the service has not reinstated the internal satisfaction surveys usually carried out directly during a physical visit on-site, however the intention is for gathering to resume in Q3 2021/22
- Adults who engaged with CLD during the first six months of 2021/22 across Banff &
 Buchan remained above the target of 80% achieving their intended learning goals,
 despite the impact of Covid-19 restrictions, with the latest quarter (July to September
 2021) seeing continued prioritisation of referrals for adult learning, and ESOL provision
 being an important delivery offer in the area. Face-to face offerings and support also

returned for literacies, with literacies remaining a current priority in Banff & Buchan. Good progress is being made for the groups involved with SQA Mental Health and Wellbeing awards and SQA Level 2 ICT awards.

- 3.5 Although the set of measures outlined above and in the accompanying appendix collectively provide a focus on our service priorities with an area perspective encompassed within the associated Directorate Plan and Area Plan teams aligned to each Head of Service within Education & Children's Services continue to collect and monitor a broad wealth of additional measures and data supporting internal scrutiny and self-assessment and providing direction for the allocation of resources and work plans at an operational level.
- 3.6 This and future performance monitoring reports are provided to assure and enable the Committee to monitor progress of delivery of the council priorities the Service is responsible for, providing a balanced overview allowing elected members to form a judgement on performance and support improvement as required in line with the scrutiny remit of the Committee.

4 Council Priorities, Implications and Risk

- 4.1 This report helps deliver the Strategic Priorities 'Education' and 'Health & Wellbeing' within the Pillar 'Our People', 'Resilient Communities' within the Pillar 'Our Environment', and 'Economy & Enterprise and 'Estate Modernisation' within the Pillar 'Our Economy', underpinned by the key principles right people, right places, right time; responsible finances; Community Planning Partnership Local Outcome Improvement Plans; human rights and public protection; tackling poverty and inequalities; and digital infrastructure and economy.
- 4.2 This report also helps deliver against the <u>Aberdeenshire Children's Services</u>
 Plan¹⁰ priorities, and the Local Outcomes Improvement Plan (LOIP) priority on Reducing Poverty¹¹.

Long trends are calculated by comparing the current value to an average of historic values in the three years preceding, e.g. Q1 2020/21 is compared to an average of all the quarterly values in the preceding three years (i.e. 12 quarters, Q1 2018/19 to Q4 2020/21).

In Banff and Buchan in Q2 of 2021/22, 77 of 83 (92.77%) of adults engaged with CLD Adult Learning achieved their intended learning goals. This is above the 80% target. ESOL provision continues to be an important delivery offer across Banff & Buchan with 23 of these adults having been assessed to attend classes, predominantly face to face. Referrals for adult learning provision have continued to be prioritised with new referrals steadily being assessed as they are received. In Fraserburgh new literacies groups have been set up which are now face to face offering people who were disadvantaged during the lockdown an opportunity to progress with their learning journeys. Literacies remains the current priority in the area and this provision is being supported by volunteers who are returning to face-to-face support. In Banff the personal development group have now all passed the first unit of their SQA Mental Health and Wellbeing Award. The ICT group are making good progress towards achieving their SQA Level 2 ICT award. Literacies remains the current priority in the area and referrals are being accommodated in either 1:1 or small group settings. Four Banff & Buchan learners were supported to attend the Celebration of Learning Event in Inverurie and of these 2 spoke to the audience about their learning journeys, the impact of CLD adult learning on their personal, community, work and family lives and were able to articulate what had changed for them as a result.
